1. Introduction

This Cookie Policy explains how Fabulous Fibres (“we”, “our”, “us”) uses cookies and similar technologies on our website and online store.

We are based in Ireland and comply with the General Data Protection Regulation (GDPR) and the ePrivacy Regulations.

By continuing to browse our site, you consent to the use of non-essential cookies if you have opted-in through our cookie banner.

2. What Are Cookies?

Cookies are small text files stored on your device when you visit a website.

They help the site work properly, remember your preferences, and understand how visitors use the site.

Cookies may be:

- Session cookies (deleted when you close your browser)
- Persistent cookies (saved until they expire or are deleted)
- First-party cookies (set by our site)
- Third-party cookies (set by trusted partners such as analytics and ad platforms)

3. Types of Cookies We Use

A. Strictly Necessary Cookies

These are essential for our website and online store to function.

Examples:

- Shopping cart and checkout
- Account log-in (if required)
- Security and fraud prevention

You cannot disable these cookies because our site won’t work properly without them.

B. Performance / Analytics Cookies

These help us understand website usage so we can improve user experience.

We may use tools such as Google Analytics (IP anonymisation enabled).



We only place analytics cookies with your consent.

C. Functional Cookies

These remember your preferences, such as:

- Language or region
- Items saved in a basket
- Log-in settings

D. Advertising & Targeting Cookies

These cookies help us:

- Display relevant ads
- Measure marketing effectiveness
- Prevent showing the same ads repeatedly

Advertising cookies require explicit consent.

4. Third-Party Cookies We May Use

We may allow trusted service partners to place cookies, including:

- Google Analytics / Google Ads
- Facebook / Meta Pixel
- Payment gateway or checkout tools (e.g. Stripe/PayPal)
- Content delivery or security tools (e.g. Cloudflare)

These third parties may process data outside the EEA, but we ensure GDPR safeguards apply.
